THE PATTERN OF ATTACKS THAT HAVE BEEN UNLEASHED ON THE MUSLIMS CLEARLY DEMONSTRATES THAT THERE IS A DELIBERATE PLAN BY THE TAMILS TO WEAKEN THE ECONOMIC AND POLITICAL STRENGTH OF HE MUSLIMS AND CHASE THEM AWAY AND MAKE THE NORTH - EAST A MONO - ETHNIC TAMIL REGION IN ORDER TO CREATE THE "TAMIL ELAM". ONE DAY

MUSLIMS SHOULD CONSIDER MORE SERIOUSLY THE PRESENT TREND AND TAKE IMMEDIATE STEPS TO SAFEGUARD THEIR LEGITIMATE RIGHTS IN AN APPROPRIATE MANNER. IF PROPER SAFEGUARDS ARE NOT SECURED NOW IT WOULD AMOUNT TO BE THE BIGGEST BETRAYAL OF NOT ONLY THE PRESENT GENERATION BUT ALSO THOSE YET TO BE BORN IN THE EASTERN AND NORTHEN PROVINCES AS MUSLIMS IN THE FUTURE.

TAMIL MUSLIM ETHNIC CONFLICT - 20-30 JUNE 2002

LTTE abducted Muslims, killed and burned them in the presence of the Security Forces of the Government in the Eastern Province. Muslims have clearly demonstrated last week that they have no confidence in the government and demanded guns for self defense. As a warning, the Muslims have attacked the residence of SLMC Parliamentarian and Deputy Minister Mohideen Abdul Cadre in Ottamawadi - Valaichenai.

Thousands of Muslims - men, women and children, have been killed and injured in the Eastern and Northern provinces by Tamil Militants since the signing of the Indo-Sri Lanka Accord on 29th July, 1987, and the Joint Statement of LTTE and MULF signed on 21st April 1988. More than 100,000 Muslims have been forced to leave their homes and many Billions of Rupees worth of properties belonging to the Muslims have been robbed and destroyed by the LTTE in 1990.

At the LTTE leader's media conference on 10th April, 2002, Mr. Anton Balasingham repeated his previous apology made at a public meeting on behalf of the LTTE for the forcible expulsion in 1990 of thousands of Muslims by the Tigers as a "political blunder" that could not be justified. Mr. Balasingham said: "Let us forget and forgive the mistakes made in the past. Tamil Elam is also the homeland of the Muslims and we have to live in harmony and amity to promote peace and prosperity in the region." LTTE Leader Pirapaharan also acknowledged for the first time that the problems of the Muslims also have to be resolved along with the problems of the Tamils.

On an invitation from the LTTE Leader V. Pirapaharan, the Leader of the SLMC and Cabinet Minister Rauff Hackeem flew in a Sri Lanka Air Force helicopter to the North with five of his party colleagues for a meeting on the 13th April, 2002.

National Leader Velupillai Pirapaharan, Political Advisor Anton Balasingham, Political Chief S. P. Thamilchevan, Batti./Ampara District Col. Karuna, Trinco. District Col. Pathuman. And Mrs. Adale Balasingham participated on behalf of the LTTE

Agreement was reached on important practical problems faced by the Muslims in the North-East. LTTE Leader Pirapaharan invited the displaced Muslims from Jaffna and Wanni to come and resettle in their own places. It was decided to established a joint committee of resprentatives from the LTTE and SLMC to facilitate the resettlement. Similarly it was decided to create favorable conditions for the resettlement of the Muslims who were displaced from minor Muslims villages in the Eastern Province.

It was decided to help the Muslims to re cultivate the uncultivated agricultural lands belonged to the Muslims in the North- East.

The LTTE agreed to cease immediately extortions from the Muslims in the Eastern Province.

It was decided to appoint an SLMC representative from each district in the North East to discuss the problems faced by the Muslims with LTTE Senior Commanders and to strengthen Tamil Muslims relationship.

It was decided to continue similar top-level meetings.

It was decided for the SLMC representatives to participate as a group on behalf of the Muslims at the negotiations to be commenced between the Government and the LTTE.

It was decided to approach the political issues of the Muslims in the North East on a policy basis and continue discussions to foster their unique political, cultural and ethnic rights.

Since the SLMC had obtained the majority support of the Muslims, it was decided to talk to SLMC on matters pertaining to the Muslims in the North East.

Though the LTTE – SLMC joint Statements dated 13th April 2002 was meant to be a breakthrough, unfortunately neither party followed up with action on the ground.

On Thursday the 20th June, 2002 a Muslim three wheeler driver called Faizal was surrounded near the 64th mile on Muthur – Thoupur road and badly beaten by LTTE Ranjan and few others on suspicion of the damages caused to the concrete crosses in the Pachchainoor malai in Muthur. Faizal pleaded innocent and said that he had nothing to do with the damages to the crosses. LTTE Ranjan is well known in the area because he is the one who collect taxes for the LTTE and issue receipts. When Faizal came home bleeding, his family members were provoked. They collected few others and went looking for Ranjan to the LTTE Office where he usually stays. For Ranjan's luck he was not there at that time. The Muslims caused some damages to the LTTE Office in retaliation for what LTTE Ranjan and others have done to Fizal.

On Friday the 21st June 2002 some LTTE cadres about 50 in number gathered with knives, sticks and iron bars close to the 64th mile post on Muthur – Thoupur road and harassed the Muslims. They blocked the road and did not allow any Muslims to go to or come from Muthur. This was in retaliation of the attack on the LTTE office by the Muslims. Muthur was under LTTE siege.

On Saturday the 22nd June 2002, Mr. K. M. (Thideer) Thaufeek, an SLMC Parliamentarian from Muthur met the LTTE local leader Mr. Ruban and discussed the incident in detail and requested him to take immediate steps to prevent the escalation of violence between the Tamils and Muslims and conduct a proper inquiry to find out who was really behind the incidents. LTTE Ruban did not show any interest to maintain peace in the area or to have an inquiry. The street block and the harassment of the Muslims by LTTE continued.

On Sunday the 23rd June, 2002; Muslim farmers and fishermen were attacked in Muthur on their way home by the LTTE cadres and the situation was tense.

On Monday the 24th June 2002, LTTE complained to the Sri Lanka Monitoring Mission (SLMM) about the attack on their office by the Muslims and security personals were placed to guard the place.

On Tuesday the 25th a Muslim called Azeez was kidnapped and the mosque at the 64th mile was also attacked by the LTTE.

On Wednesday the 26th June 2002, a harthal was organized by the LTTE in the North East to protest over some incidents in Velanai – Jaffna and the attack on the LTTE office by the Muslims in Muthur. A procession with about 500 LTTE cadres started from "Pachchainoor Malai" and came to Muthur.

Although it was said to be a peaceful hartal procession, the Tamil youths were carrying knives, sticks and iron bars and forced the Muslims to close their shops and business places and they threatened to set fire to a petrol pumping station in the Muslim area. The Muslims cooperated and closed their shops but resisted any attack on the petrol pumping station and the clash between the Tamils and Muslims started. 43 shops — **Annexure I,** and seven houses belonging to the Muslims were destroyed by the LTTE who came in the peaceful procession. They also removed the barbed wire fence to the paddy fields and drove the cattle in to destroy nearly 700 acres of paddy. Police imposed an unofficial curfew in the area. Although the violence in Muthur subsided, the area was tense as people left their homes and sought refuge in temples and mosques.

On Thursday the 27th June 2002, few Muslims Thiologians "Ulemas" organized a meeting with some Catholic priests to maintain peace in the area. SLMC leader and Minister Hackeem also spoke to LTTE Pulithevan regarding Muthur crisis.

A peaceful harthal was organized by the North – East Muslim Brotherhood Movement and Muslim Students Union in the Eastern Province to protest over the LTTE attack on Muthur Muslims and unlawful extortion and abduction by the LTTE in the Eastern Province. What worried the Muslims most is the extortion from the Muslims after the ceasefire agreement (MoU) in the areas under the control of the government and when complained the government did nothing other than a formal complain by the Peace Secretariat to the Norwegian government and Sri Lanka Monitoring Mission (SLMM)

In order to defy the harthal organized by the Muslims, the Tamils drove the buses from Tamil areas through Muslim Villages. These buses were stoned at Ottamawadi a predominant Muslim area. An ambulance went through Kattankudi was also attacked. Consequent to these incidents violence erupted in Valaichenai between the Tamils and Muslims. LTTE abducted 12 Muslims and killed. **Annexure II.** More than 100 were injured. 238 Muslim shops **Annexure III.** were burned and destroyed. 5

houses were also burned. The values of damages were estimated to be Rs. 97,998,141.00.

On Friday the 28th June, 2002; Valaichenai Pradeshiya Sabha Office was set on fire and destroyed. In the grenade attack on Muslims returning from Friday "Jummah" prayers, 7 were injured – 2 critically. Additional troops and Special Task Forces were Air lifted after the mortar shells were fired and grenades were hurled at the Muslims by the Tamils. The Batticaloa and Ampara District were placed under curfew.

On Sunday the 30th June 2002, two bodies were found by the police in Kalmadu Village in Valaichenai. They were the two Muslim cooks who went to the house of a Tamil in Valaichenai, on Wednesday the 26th June, to prepare the wedding meals. The LTTE cadres have abducted the two Muslims killed and buried them in a shallow pit in the paddy field. The father and few members of their family went to identify the bodies. After the postmortem, the police loaded the dead in a tractor trailer to be taken for the burial according to Muslim rites. But the LTTE cadres with arms objected the removal of the bodies and insisted the burning of them in situ. The Army Major Hettiarachi contacted the Head Quarters and he was given the orders to leave the bodies and avoid any confrontation with the LTTE. Then the LTTE cadres put the bodies on a heap of tyres and burned them in front of the Army and Police and destroyed all evidence of the horrendous human rights violation of the LTTE.

When the SLMC leader Hackeem visited the area, the Muslims stopped his vehicle on the way and shouted "give us the guns we will defend ourselves. The Government Army and Police are helpless" A fact finding mission led by Minister Milinda Moragoda and Army Commander Lionel Balagalla visited Valaichchenai in the East and the analysis maintain that the continuation of the violence for such a long period is not possible without local LTTE support.

SLMC leader Hackeem questioned how it was possible for the Tamils to get the mortar launchers to attack the Muslims without the support of the local LTTE. LTTE being the sole representative of the Tamils in the North East, it is a shame for its leaders that they were unable to control their men attacking the Muslims in the East.

Up to date no hard facts have been established to prove who was behind the attack on LTTE in Velanai, Jaffna and the attack on the concrete crosses on "Pachchainoor Malai" in Muthur. In the case of Velanai the two LTTE Cadres who claimed that they were attacked by the EPDP and Government troops, interestingly escaped unscathed despite the wide publicity to the incident. Beside it is now learnt that the EPDP cadre "Kanthan" whom the LTTE had implicated in the attack was elsewhere at the time mentioned by the LTTE, attending is own wedding engagement ceremony.

On the other hand in Muthur, there is an Army camp, a Police Security Check Point and a Hindu "Pilliyar" temple within 200 meters of the site "Pachchainoor Malai" where 14 concrete crosses have been erected recently by few Tamils who have been converted to Christianity. The attack on the concrete crosses also raises a pertinent

question as to why the Muslims who have no interest over the conversion of Hindus to Christianity or the erection of a Church close to a Hindu Temple, should take such a serious risk of breaking the 13 concrete crosses close to the Army and Police Security Point.

LTTE international propaganda machineries, Tamil Parliamentarians and the local Tamil media have maliciously blew up out of proportion the minor incident at the LTTE office in Muthur and suppressed the horrendous Human Rights Violation of the LTTE during ceasefire, against the unarmed Muslim civilians under the pretext of peaceful harthal in the North East.

TULF General Secretary Mr. R. Sampantan, M.P., accused a Muslim group calling itself "Osama Group" for starting the violence in Muthur. But Muthur Police had denied the existence of such a group operating in Muthur area.

"The Island" News Paper of 1st July 2002 reported a soldier saying that he had seen the local LTTE cadres among the mobs that attacked the Muslims in the East. LTTE continue to violate the MoU and no body is taking any action against them. What is the Monitoring Mission doing? They have shown their incompetence over and over again. The TNA Members of Parliament have become LTTE pawns and continue to add fuel to the fire.
